such events and linguistically they could have specific local meanings, which we should describe; in English: relocation, displacement, replacement, dispossession, eviction, dismissing, dispelling, outcasting etc, for example in Romanian "strămutare")

Observation: We might be blamed for a negative bias regarding case selection, but this is our methodological option: we want to understand a phenomena that has negative consequences on people's life (by this we do not affirm that there are not "good practices", but it is not our aim investigating them)
